RESERVATION FOR SC/ST

Department of Personnel & Training, Govt. of India, have clarified vide OM No. 36012172002 Estt. (Res.) dated November 6, 2003 that after introduction of Post based Reservation, it is not permissible to fill up the post, reserved for ST by a SC candidate or vice-versa by exchange of reservation between SC/ST categories.

In view of the above, it is brought to the attention of all concerned that no exchange of vacancies is allowed between SC & ST categories even if no eligible candidate is available under either of the above two categories. Hence, panel will be drawn keeping in view the above amendment in our subject notice.

RESERVATION FOR PwBD

Norms as stated under Para 2.2 of DoPT OM No. 36012 / I / 2020 - Estt. (Res.-II) dated 17.05.2022, will be applicable.
