1. The Uttar Pradesh Pollution Control Board invites online applications from Indian citizens for recruitment to 26 temporary posts of Assistant Environmental Engineer, Pay Matrix Level-10, and 14 temporary posts of Assistant Scientific Officer, Pay Matrix Level-10. The number of vacancies may vary. The category-wise breakdown of these posts is as follows:

**Horizontal Reservation** - This shall be applicable in accordance with prevailing latest orders issued by the Government of Uttar Pradesh for the advertised posts.

**2. Guidelines for Filing Online Application :-**

Candidates are advised to carefully read the following instructions before filing the Online Application.

**2.1 General Instructions for Application:**

- (i) Applications shall be accepted only through the dedicated Online Application System. The link **Assistant Environmental Engineer and Assistant Scientific Officer Examination-2026** is available at the official website of the Uttar Pradesh Pollution Control Board: [www.uppcb.up.gov.in](http://www.uppcb.up.gov.in). The guidelines for registration and filing online application is also available in this link. The applications submitted through any other mode shall not be accepted. Candidates must follow Instructions for filling the online registration and application form. Incomplete or incorrect applications are liable to be rejected at any stage of the recruitment process.
- (ii) Candidates are advised not to wait until the last date to submit their online applications.
- (iii) After online submission of application, candidates should print and retain a copy of the submitted application form for future reference. For verification purpose the

candidates are required to produce the copy of application form and self-attested copy of Educational Qualification proof, Caste Certificate and other relevant documents as mentioned in their application form as and when required. No request for withdrawal of the submitted online application form shall be entertained.

- (iv) After the last date for submission of online application, Admit Cards and other important information shall be available only on the link **Assistant Environmental Engineer and Assistant Scientific Officer Examination-2026** at the official website of the UP Pollution Control Board ([www.uppcb.gov.in](http://www.uppcb.gov.in)). The applicants are advised to check this link for updates.
- (v) Entries made in the last submitted online application form shall be treated as final including the name of applicant, post applied for, caste, date of birth, address, e-mail ID and mobile number etc.
- (vi) Applications without prescribed fee and required documents as mentioned in the recruitment process shall not be considered.
- (vii) Uttar Pradesh Pollution Control Board (UPPCB) reserves the rights to allot the examination centres for the candidates and no representation in this regard shall be entertained by UPPCB.

### 3. Application Fee :-

The category wise prescribed application Fee is as follows :-

- Note: (1) Dependents of freedom fighters, ex-servicemen, and female candidates are required to pay the fee as per their original category mentioned above from serial number 1 to 5.
- (2) Bank charges in addition to the application fee will be borne by the candidate.
  - (3) The examination fee must be paid only through the online payment gateway available in the link for Assistant Environmental Engineer and Assistant Scientific Officer Examination-2026 on the website of Uttar Pradesh Pollution Control Board [www.uppcb.gov.in](http://www.uppcb.gov.in).
  - (4) The application fee once paid will neither be refunded/transferred nor held in reserve for any future examination process.
  - (5) Demand draft/cheque/money order/postal order/banker's cheque/postal stamp etc. will not be accepted as application fee.
  - (6) If candidates wish to make any amendments to their submitted application, they may submit a second application (second registration) online within the prescribed deadline,

with the revised information, by repaying the application fee. The fee deposited in the previous application will not be refunded under any circumstances and will not be adjusted against the second application.

#### **4. Essential Qualifications:**

##### **4.1 Educational and Experience -**

###### **(a) For the post of Assistant Environmental Engineer -**

A Bachelor's degree in Chemical Engineering/Chemical Technology/Civil Engineering/Environmental Engineering from a University established by law in India or a qualification recognized by the Government as equivalent thereto. (Any equivalent qualification shall include a qualified Associate Member of the Institute of Engineers India (AMIE) in Chemical Engineering, Civil Engineering, Environmental Engineering branch.)

###### **(b) For the post of Assistant Scientific Officer -**

A Doctorate in Chemistry/Zoology/Botany/Biochemistry from a University established by law in India or a qualification recognized by the Government as equivalent thereto with three years of experience in the field of Environment/Pollution Control/Public Health,

OR

A Master's Degree in Chemistry/Zoology/Botany/Biochemistry from a University established by law in India or a qualification recognized by the Government as equivalent thereto with five year of experience in the field of Environment/Pollution Control/Public Health.

(A Doctorate in Chemistry/Zoology/Botany/Biochemistry or a Master's degree in Chemistry/Zoology/Botany/Biochemistry from a University/Deemed University or Institute established by law by the Central or State Government under any qualification recognized as equivalent thereto)

##### **4.2 Age Limit:**

- (1) The minimum age of a candidate must be 21 years and the maximum age must be 40 years as on July 1, 2025. Only the date of birth mentioned in the High School or equivalent examination certificate will be considered for calculating the age of the candidate.
- (2) A relaxation of 5 years in the maximum age limit will be admissible for candidates belonging to the Scheduled Castes of Uttar Pradesh, Scheduled Tribes of Uttar Pradesh, Other Backward Classes of Uttar Pradesh, skilled sportspersons of Uttar Pradesh classified sports (this relaxation will be applicable only to candidates domiciled in Uttar Pradesh) and employees of the State Government of Uttar Pradesh, as per rules.
- (3) Ex-servicemen (Ex-Servicemen) who have served for at least 5 years will be granted a service period relaxation of 3 years in addition to their years of services and

maximum relaxation will be limited upto 15 years. Retirement from the armed forces by the last date of application is mandatory.

- (4) Candidates belonging to the disabled category will be eligible for a 15-year age relaxation as per rules.

## 5. Reservation -

Details regarding reservation for Scheduled Castes of Uttar Pradesh, Scheduled Tribes of Uttar Pradesh, and Other Backward Classes of Uttar Pradesh are given in Para 1 above.

**Note** - For candidates to avail reservation benefits and exemption in application fee, only the caste certificate of Scheduled Castes and Scheduled Tribes of Uttar Pradesh, Other Backward Classes of Uttar Pradesh, and for economically weaker sections (EWS) a certificate issued by the competent authority in the format prescribed by the Government of Uttar Pradesh will be accepted. It is mandatory to upload the certificate issued by the competent authority of the State Government in the prescribed format in the online application form. The applicants are required to produce original copy of the same as and when required by UPPCB.

## 6. Selection Process-

Candidates will be selected on the basis of a Computer Based Test (CBT) and interview. Selection for the posts advertised in this advertisement will be done under the provisions of the "Uttar Pradesh Pollution Control Board Service Regulations, 1995, as amended." The Information regarding the date of the Computer Based Test (CBT) examination will be available on the link for Assistant Environmental Engineer and Assistant Scientific Officer Examination – 2026 at Uttar Pradesh Pollution Control Board website [www.uppcb.gov.in](http://www.uppcb.gov.in). The total marks for selection will be 470.

### 6.1 The examination will be conducted in two stages as follows:

A. **Stage I** - Computer Based Test (CBT) will be objective type and will carry 400 marks. The test subjects, maximum marks, negative marking, and time allotted will be as follows:

#### (i) For the post of Assistant Environmental Engineer –

**(ii) For the post of Assistant Scientific Officer –**

- (i) Each question will have a total of 04 (four) options. There will be 04 (four) marks awarded for each correct answer, 01 (one) mark will be deducted for each wrong answer, and 0 (zero) marks will be awarded for questions not attempted. Question Paper will be available in English & Hindi. In case of any discrepancy in interpretation of questions, English version shall be considered final.
- (ii) A merit list will be prepared based on the marks obtained in Computer Based Test (CBT) and the candidates from this merit list will be called for interview as per prescribed rules.

**B. Second Stage :** Interview carrying 70 (seventy) marks.

**6.2 Selection -** Based on the marks obtained by the applicants out of 470 marks mentioned above, the merit list will be prepared as per the provisions of the existing rules/regulations and selection will be made accordingly.

**7. General Instructions for Candidates -**

- (1) All candidates belonging to reserved categories of Uttar Pradesh must mention their category in the application.
- (2) The candidate will be given reservation benefits for the reserved category for which he/she applies.
- (3) Candidates belonging to Scheduled Caste, Scheduled Tribe, Other Backward Class, dependents of freedom fighters/ex-servicemen, persons with disabilities and women candidates who are not domiciles of Uttar Pradesh are not eligible for reservation benefits. Such candidates will be treated as belonging to the unreserved category. In case of women candidates, only the certificate issued by the father's side will be acceptable.
- (4) Ex-servicemen and persons with disabilities will submit their claim on the basis of a certificate issued by the competent authority on the format prescribed by the Government of Uttar Pradesh, otherwise the claim made by the candidate will not be accepted.
- (5) The caste certificate of such women candidates, in which the benefit is sought merely on the basis of her being the wife of a person belonging to the Scheduled Caste or Scheduled Tribe or Other Backward Class category of Uttar Pradesh, will not be accepted.

- (6) Candidates who claim to be dependents of freedom fighters of Uttar Pradesh should ensure that the certificates submitted by them are in the format enclosed with the Government Order dated 21st April, 2015 issued in pursuance of the Uttar Pradesh Public Service (Reservation for Physically Handicapped, Dependents of Freedom Fighters and Ex-Servicemen) Act, 1993 as amended and that the freedom fighter is a resident of Uttar Pradesh or He/She and the candidate is (1) son and daughter (married or unmarried) or (2) grandson i.e. (son's son or daughter's son) or granddaughter i.e. (son's daughter or daughter's daughter) of the freedom fighter, whether married or unmarried.
- (7) Candidates who claim to be physically handicapped should ensure that they possess a disability certificate issued by the competent authority on the updated format prescribed by Government Order No. 5/2022/18/1/2008/47/Ka-2/2022, dated 18.04.2022 of Personnel Department-2 of Uttar Pradesh Government and the certificate should clearly mention the type and percentage of disability of the candidate.
- (8) Candidates serving in the Central or State Government shall obtain a No Objection Certificate from their employer and submit it to Uttar Pradesh Pollution Control Board on demand.
- (9) Male candidates who are married and have more than one living wife or female candidates who are married to a man who already has a living wife will not be considered eligible unless the Governor of Uttar Pradesh has granted exemption from the above restriction.
- (10) The decision of the appointing authority regarding the eligibility/non-eligibility of a candidate will be final.
- (11) For candidates to avail the reservation benefits, relaxation in maximum age and exemption in application fee, only the caste certificate of Scheduled Castes and Scheduled Tribes of Uttar Pradesh, Other Backward Classes of Uttar Pradesh, and for economically weaker sections (EWS) a certificate issued by the competent authority in the format prescribed by the Government of Uttar Pradesh will be accepted. For Ex-serviceman the certificate issued from the competent authority is essential.
- (12) Any candidate providing false information in their application form that cannot be substantiated by the certificate shall be disqualified from this examination and selection process related to this advertisement and all other examinations and selection processes.
- (13) It is mandatory for the candidates to produce the original and self-attested copies of documents related to age, mark sheets, degrees at the time of interview.
- (14) The Candidates who are found non-eligible later will have their candidature/selection cancelled, and the decision of the appointing authority in this regard shall be final.
- (15) The Candidates will be allowed provisional permission for the written examination based on the information provided by them. However, if it is later found at any stage that the candidate was non-eligible or that his or her application was not acceptable at

the initial stage, the candidature will be cancelled, and even if an appointment has been made, the appointment will be cancelled.

- (16) The Applicants should retain the hard copy of their application form. There is no need to send a separate hard copy of the application to the office of Uttar Pradesh Pollution Control Board. Candidates must present a hard copy of online submitted application at the time of interview.
- (17) Any malafide act such as cheating, indiscipline, misconduct, or undesirable conduct and use of unfair means in the examination hall will result in the cancellation of the candidature. Any violation of these instructions may lead to the disqualification of the candidates from this and any future examinations.
- (18) The candidates selected for appointment will be required to undergo a medical examination by the Chief Medical Officer, and the examination report must be submitted upon joining.
- (19) The candidates must possess all the required qualifications and eligibility criteria as on 28-02-2026.
- (20) The Uttar Pradesh Pollution Control Board does not provide any separate advice to candidates regarding their eligibility. They should therefore carefully read the instructions of this advertisement and apply only after satisfying themselves that they are eligible as per the conditions of this advertisement.
- (21) The appointing authority reserves the right to cancel the candidature/appointment in case of any misconduct, concealment of important information, pending prosecution/criminal cases, conviction, having more than one living spouse, misrepresentation of facts, or making recommendations regarding candidature/selection.
- (22) In case of any dispute, the place of jurisdiction shall be Lucknow.
